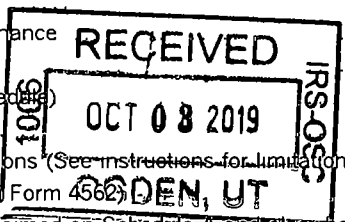

STATEMENT 1

Amended Return Explanation

The organization is filing an amended tax return to correct an error in the tax computation on the original return. A summary of changes and explanations follows:

Per Publication 598, "Tax on Unrelated Business Income of Exempt Organizations," Chapter 4, "All dividends, interest, annuities, payments with respect to securities loans, income from notional principal contracts, and other income from an exempt organization's ordinary and routine investments that the IRS determines are substantially similar to these types of income are excluded in computing unrelated business taxable income."

However, two pension distributions that had Federal backup withholding were incorrectly included in the organization's unrelated business taxable income. Thus, this amended return is being filed to remove these distributions from the organization's business taxable income and claim a refund of the backup withholding and a refund of the tax paid on the original tax return related to this income.

LINE 49 - OVERPAYMENT

The tax paid with the original return was \$2,645, and backup withholding was \$5,407. We are requesting a refund of both amounts, for a total of \$8,052. \$ 8,052
